



STRO & CO. TRAVEL DESIGNS TERMS & CONDITIONS

By making a deposit payment for this itinerary I confirm that I read the Disclaimer, Booking / Payment Policy, Changes to Itinerary, and Cancellation Policy and agree to the terms. I authorize Stro & Co. Travel Designs to charge the credit card provided herein.

Payments can be made by credit card, bank transfer, mobile app transfer (Cash App: \$LeighStrothersPA), (Zelle: Stroandcotravel@gmail.com), (Pay Pal: Leigh.Strothers@yahoo.com), cash, or certified check. Personal Checks are accepted on a case-by-case basis. Money Orders are not accepted.

Please refer to the Digital Itinerary for complete trip details including the above policies, hotel, excursion, and transfer information.

IMPORTANT TRIP-RELATED INFORMATION:

- A valid passport is required for travel when traveling internationally. Passports must be valid for at least 6 months after your travel RETURN date. It is the responsibility of the traveler to insure their passport meets the requirements of the destination they are traveling to.
- Travel Protection is not included in the standard package price. Insurance can be added through Stro & Co. or purchased independently. Stro & Co. Coverage must be added no later than 7 days after initial deposit. Please ask about pre-existing conditions at the time of booking.
- This is a Land Only Quote. Pricing for International Flights are NOT included in the cost of this itinerary. International Flights can be booked independently or added to your itinerary, at your request.
- Group Flights: Group flights will sometimes be sourced for Stro & Co. Hosted Groups. All Travelers on the Registry will have the opportunity to add International Flights with the Group once pricing is available.

- Quoted Rate is based on Double Occupancy. Solo Travelers must pay a supplement as noted in the itinerary. Final room assignments are due on 120 days prior to travel. Name changes after this date will incur a fee of \$100.

BOOKING / PAYMENT POLICY:

- Each traveler is required to register in the same name that is shown on their passport. Failure to do so may result in name change fees for the traveler.
- A required, non-refundable Planning Fee of \$100 per person is required to reserve space on the Travel Registry. If not paid in advance, the Planning Fee will be added to your Initial Deposit.
- A non-refundable Initial Deposit of \$200.00 pp is due as per trip payment schedule (Planning Fee to be added where applicable.)
- A required minimum monthly payment of \$100.00 per person is due by the 15th of every month as per trip payment schedule
- Final payment due as per trip payment schedule.
- Each traveler must adhere to the monthly payment schedule previously set forth. Late fees will be assessed on the 15th of each month. Late fees will consist of 12% of the past due balance.
- Monthly payments are required to keep your reservations current. A reservation that has gone 60 days without a monthly payment can be cancelled without notice.
- Official itineraries and travel documents will be issued approximately 30 days prior to departure.
- In the event of a cancellation where the occupancy booked is double or greater, travelers who remain on the booking will be 100% financially responsible for any remaining balances owed since the booking will automatically adjust to the true occupancy held. This will apply even if the remaining travelers have paid their reservation in full.

CHANGES TO ITINERARY:

- The official itinerary will not be established until all reservations are confirmed and travel documents are received. Specific items such as excursions, hotels, room types, etc. may be substituted with similar options with identical star/class ratings.

CANCELLATION POLICY:

- The following cancellation fees will apply to all canceled reservations. This fee is per person, per reservation, and is in addition to any other cancellation fees that may be associated with your booking. **All monies paid are non-transferable.**

Please note the following non-refundable amounts:

- Stro & Co. Planning Fee is non-refundable.
- Initial deposit is non-refundable
- First trip payment after deposit is non-refundable (up to \$200)

AIR:

- Fully paid & Ticketed Flights: As per airline rules. Full details will be advised upon confirmation of the regional flights, and the written contract is received from the airline. (if applicable)

LAND ARRANGEMENTS:

- More than 125 days prior to departure loss of non-refundable amounts, plus fees and surcharges as applied by hotel/lodge/tour companies.
- Between 124-75 days prior to departure 75% of the gross tour price
- 74 days or less prior to departure 100% non-refundable

Important Note: Cancellation penalties for some travel arrangements may differ from the general conditions. In this occurrence, you will be advised of these addendums at the time of confirmation or prior to any penalties becoming applicable and as soon as we are notified of these special conditions.
